WELCOME TO THEATRICAL EMPLOYEES LOCAL B18

I would like to take this opportunity to welcome you as a new member. Thank you for completing the I.A.T.S.E. Local B18 membership application. You will be enrolled in Local B18 as a member when your application is approved by our General Office in New York.

Your initiation fee is \$60.00. Please send a check/money order for initiation plus the appropriate dues for your first quarter, so that we may process your application. It is from this amount that the fee required by I.A.T.S.E. will be submitted to the International on your behalf.

Dues are based on what you earn at B18 venues:

- \$42.00 per quarter if earnings are \$2500 or more per quarter
- \$34.00 per quarter if earnings are less than \$2500 per quarter
- \$20.00 per quarter if you are inactive (no work at a B18 venue)

After your initial payment, these are payable at the beginning of each quarter (January, April, July, and October). Dues not paid by the fifteenth (15th) day of the first month of each quarter are considered late and a penalty of \$2.00 shall be levied for each week in which dues remain unpaid. Your attention to being up-to-date with dues creates administrative efficiency for the Local and is greatly appreciated.

I will send your Union Card as soon as your application is processed through I.A.T.S.E. You may submit your Union Card with each quarterly payment and it will be returned to you with a stamp reflecting your payment.

An open B18 General Meeting is held at the Local's office on the second Monday of January, April, July, and October at 6:30pm.
